Regular Meeting - July 25, 2018

- 1. Call to order by Mark Hyde
- 2. Board members present
 - a. Rick Timmerman, Mark Hyde, Steven Bendix, and Melanie Virgilio
 - i. Absent. Jon French
 - b. Audience
 - i. Marc Johnston (Road Foreman)
- 3. Session recorded by GNAT-TV
- 4. Approval of minutes from June 18, 2018
 - a. Motion made to approve the previous meeting minutes by Bendix, seconded by Virgilio, motion passed
- 5. Report from Road Liaison and/or Highway Foreman
 - a. Stormwater management grant personnel in town working
 - b. Paving has been completed
 - c. Line painting postponed due to weather, will continue next week
 - d. Pipes on Kelley Stand, Maggies Run, South Road, Matteson, Prouty Hill, and Barney Orchard ordered
 - i. Waiting on some materials to begin projects
 - ii. Prouty Hill resident will take some fill during/after project
 - e. Railroad track area flattened out
 - f. Ditching on South Road and North Road
 - i. Hyde asked when remaining tree removal will be completed on North Road
 - ii. Johnston said it is on his list
 - iii. Any road with more than a 5% grade will require stone line ditching for stormwater

- iv. High water warning advisory sign received, will be installed near Casella's
- g. Grading will be completed next week on Kelley Stand
 - i. Rock slide area needs to be dug out
 - ii. Johnston suggested installing a sign warning not to stop in area,Timmerman agreed
 - Virgilio asked if netting could be installed to prevent further rock slides, Timmerman and Hyde commented that it would be an expensive project
- h. Radar has been installed on South Road
 - Timmerman asked for other location suggestions: North Road and Sunderland Hill Road
 - It will be left on South Road for now, Johnston will scout for places on North Road
- Sunderland Hill Road closure due to road work will take place August 20-24th
- i. New truck
 - i. Should be ready in October
 - ii. Old truck will be sold to private party
 - Johnston will contact interested party for purchase, will keep until new truck arrives

k. Salt

- i. Still waiting for state bid
- ii. Johnston suggested that the Road Crew apply the magnesium chloride treatment, will allow more flexibility
 - Bendix asked about health concerns, Johnston said it is fairly safe, Timmerman warned against corrosive properties
 - Timmerman recommended looking into an application system in the future

- Johnston shared that the prewetting system is hard to maintain

 - Motion made by Timmerman to hold over \$9,500 for chloride in Highway Fund from last fiscal year to the current fiscal year, Bendix seconded, motion passed
