5. Treasurer Update

Eric Hatch reported they still don't have a treasurer. Eric and Jonathan spoke about possibilities, but BCRC is not able to assist with this. Eric added Southern VT CUD needs to get someone one their own for record keeping. Sheila Kearns said the current treasurer continues to write checks and respond to bills. 6. BCRC CUD roles

Eric Hatch updated the Board he and Sheila have had discussions with Jonathan from BCRC regarding executive support, activities, and deliverables BCRC can help with. Eric said both requests have been returned to NTIA, they have confirmed receipt of the submission and now they are waiting to hear back from NTIA.

Grant Funding

Jeb Rubin suggested advertising for a Treasurer, Eric said they need money before they advertise – he is hopeful some money will come in from H.315 or H.360 from the State. Sheila asked Jonathan what the next steps are to get the H.315 money that has been granted released. Jonathan said the first step is to submit an invoice and Melanie submitted that in the last week or two. Jonathan said the next step would be to make sure the language in all the agreements is in place to meet federal standards. Jonathan will reach out to Rob Fish to make sure he has everything he needs. Eric Hatch said they are 2 months in the rears for reporting and will need to get those to Rob, he will work on submitting them this week and confirm with Jonathan when that is complete.
