- 4. 412 Kelley Stand Road application site plan review Godkikian/Ryan. Mr. Godkikian present for applicants. Review of past actions. Mr. Godkikian has provided all information Commission has requested. Permit approved with conditions as outlined in State letter of May 19, 2021. No new net fill on property, construction area to be staked out, and acknowledgement that height of building will be under 30 ft. Permit will be issued.
