## 8. 2022 Annual Report Hearing

#### 10. Other Business

Eric Hatch met with BCRC to discuss the possibility of BCRC assuming the executive director role in 2023. The responsibilities would be split between Jonathan Cooper and Callie Fishburn. This will help streamline communications by having BCRC be a single point of contact for the CUD. This idea is being introduced to the board at the board, with the expectation that there will be a more formal agreement for the board to vote on at the next meeting.

Andrew McKeever asked about the FCC's updated broadband data map and what it means for Southern Vermont. Terence Dorsey recommends that people who are concerned, should go to the FCC's broadband website, review their address in the database, and if they feel the data are inaccurate, they should submit a challenge. The Public Service Department is working with a consultant to review the data and submit a state challenge. TD believes that this issue should be handled by the state because of the complexity and expertise required to analyze and vet the data. Sheila Kearns reported that the process for submitting an individual challenge to the FCC is not very straightforward and this should be kept in mind when directing people to submit individual challenges. TD said that individual challenges are treated differently than state-level challenges, and will likely be treated as consumer complaints.

Quorum issues: Sheila Kearns suggested getting phone numbers for town representatives so that they can be reminded of meetings by phone as well as email. Eric Hatch did a recent clean-up of the Google email list of board members, but Callie and Jonathan will take a look at the list and possibly reach out to representatives individually about attending meetings.

The next regular meeting on December 28<sup>th</sup> will be cancelled. The board will reconvene in January, and will begin offering an in-person meeting location again.
