Meeting Minutes

1. Call to Order- Meeting CTO at 7:00 PM by board Chair Jon French
2. Introduction of Board Members and speakers- Alex Bresnick, Dixie Zens, Jon French-Chair, Andrew McKeever and Bruce Mattison all present. Also present Marc Johnston-Road Foreman, Caroline and Ian Hartshorn.
3. Approval of Minutes from March 27, 2022 meeting.-Motion to accept made by Mr. McKeever second by Mr. Mattison 4 Yays, 1 abstention, motion carried.
4. Public Comment- Caroline Hartshorn would like members of both Planning and Select boards to watch how they speak about fellow residents, mainly those that live in trailers.

Price for a compactor to install on back of grader is \$42,725., it is a wish-list item.
