Eric Hatch has scheduled a meeting with NEK Broadband on Friday, April 14th to discuss marketing and fiber buildout in Southern VT.

8. Act 71 Grant Updates

The first quarterly report is almost ready and will be submitted by the April 15th deadline. Several required permits for highway crossings, railroad crossings, and pole attachments have been approved with a few others pending.

9. Town Outreach About Construction Phases

CCI has begun direct outreach to town staff and officials about construction, which will begin on April 17th at the Manchester, South Londonderry, Stratton wire centers. Customers served by those wire centers should be eligible for service by November 1, 2023. Other upcoming wire center construction dates:

Arlington – 6/15/23 Pownal – 7/15/23 Dorset – 5/15/23 Rupert – 7/17/23

Field inspection of each wire center by VCBB should occur approximately three months after construction begins.

Board representatives are encouraged to share these dates with residents and town officials.

CCI is doing direct outreach to towns about upcoming construction and may be available to attend select board meetings as requested.
