## **MERP Act 172 Assessments:**

Jan15th deadline has been moved up to Oct 31st to apply for energy assessments (a/k/a energy audit). Our Town garage already completed an energy audit so may only need to have that report reviewed. A full, level 2 Energy audit for Town Hall.

Energy audits need State approval and are required if we are to request Act 172 (MERP) funding to make our two buildings more energy efficient and self-reliant.

#### **Green Procurement:**

The proposal to be presented to the Select Board for review is complete and unanimously agreed upon. The proposal will be a Memorandum of Understanding rather than a Policy.

Select Board meeting: Sept 11th. The document may be ready for the board for discussion at the October meeting. If not, it will be presented at the next SB meeting.

SEC board votes to send the proposal to the Select Board. Jeff will contact Dixie to get it on the Agenda.
