8. Act 71 Grant & Construction Updates

Pownal and Rupert are the last wire centers being completed and are expected to open up for sales later this month. This will complete Phase 2 of the build and allow the CUD to focus on developing a plan for Phase 3 addresses. Bill and Arlene asked promotional plans in Rupert – Sheila responded that the best way to be notified about availability of service is to pre-order on the Fidium website. Susan Lenox reported that nearly the entire town of Landgrove is connected with Fidium using this method.

9. Review of Phase 3 Letter to Landowners

Callie Fishburn drafted a letter to Phase 3 landowners which was reviewed by the board. Edits suggested by board members will be incorporated, and the letter will be mailed out in the next few weeks.

10. Treasurer Transition

Al Bashevkin will be stepping down from his role as CUD treasurer in October. A possible new treasurer has been identified; Jessica Grimm-Lyon who has a bookkeeping background is interested in the position and would be able to start in October. The board thanked Al for his work as treasurer.

11. Other Business

The board discussed the most recent VCBB meeting where Act 71 applications from Otter Creek CUD and Lamoille Fiber were discussed. VCBB approved both applications with a number of provisos, including a sustainability plan. Otter Creek and Lamoille have similar situations to SoVT CUD and the board discussed potential resource sharing amongst the three CUDs.

Tim Scoggins has put together a press release announcing 95% fiber coverage in the region. This could be the first part of a larger marketing and outreach campaign about fiber coverage in the region which could be used to attract new residents and businesses. The press release can be shared with local media outlets in the tristate area, as well as existing news segments from GNAT and NBC Channel 5. This is also an opportunity to educate people about the larger statewide effort to expand broadband access.
