8. Emergency Management Coordinator's Report – Todd

- Discussed the latest severe storm + tornado warning. No reported damage
- Looking at options to utilize social media or other formats to distribute information to the public
- Mentioned with the recent heat wave, the state has begun promoting cooling sites. Sunderland does not have one. Todd mentioned that if the energy committee is still exploring mini split units that cooling site at Town Office is another positive
  - Rob Zeif asked about state grants. Todd will look into it.
  - Thomas Dykeman inquired about what a cooling site is. Todd explained
  - Maria Timmerman mentioned about local libraries as cooling sites

13. Zoning Administrator Report – David Kiernan

- Casella hearing on Wednesday 06/26 regarding adding two maintenance bays at transfer station
- STR moving from bylaw to ordnance per advice of town attorney
  - Changes enforcement action and allows for residents to file complaints instead of only Town Zoning Administrator or Town Health Officer
- New ordinance hearings will most likely be in August and Bylaw hearings will then cease
- New ordinance revisions posted in town office for review
- Linda Dykeman asked question if cap on amount of STR's in town has been proposed
  - Dave Kiernan states that there are no current limits at this time and has not been proposed
- Rob Zeif asks if the Town Attorney signs off on changes does that mean we have to start the process over again?
  - Dave Kiernan states that we need to start process over with Selectboard but not the Planning Commission portion
