- 1. Call to Order by Dixie Zens at 7:00 pm.

- 4. Public Comment- Melanie Virgilio
  - T&G provided an update on the fiscal feasibility of operating 5 schools in the district.
     Cites costs and low enrollment. T&G will be meeting Monday Sept 9th at 6:30pm at
     Sunderland Elementary School regarding the future of the school and consolidation.
     Initial meeting only and will not be a final vote. Informs board that if the school did close,
     the town could possibly buy back the property for \$1
  - Todd inquired if other schools in the district are at risk
    - Melanie informed that Sunderland is the school that is at the bottom of the list
    - One other school has same challenges in district
- 5. Review and discussion on the proposed Short Term Rental Ordinance David Kiernan
  - Switch from proposed bylaw to ordinance was mainly for enforceability
    - Ordinance allows for violations to be reported by residents
    - Bylaw required violations to be witnessed by Zoning Administrator

- STR units are also regulated under the VT Division of Fire Safety
  - Operators have health and safety responsibilities to their guests
  - o Requirements for fire/life/safety (FLS) are separate from ordinance
- Proposed Ordinance is posted on town website
- Next steps in Ordinance adoption:
  - Selectboard will need to adopt ordinance
  - 15 day notice is required so looking at 2nd Selectboard meeting in September

#### 6. Sunderland Church Restoration Update - Rob Zeif

- Northshire Community Land Trust (NCLT) has requested changes and comments to proposed MOU
  - If ownership transfer moves forward, the Sunderland Church under Northshire Community Land Trust would ask Town of Sunderland for assistance seeking grants
  - Town of Sunderland still would not be required to contribute town funds
  - o Town requests for no fee and reasonable use of structure and property
- BCRC will be attending Planning Commission meeting on 08/28
- Stephens and Associates beginning survey Wednesday 08/28
- State will be paying for environmental studies
  - If NCLT interest falls through then having studies completed might help town for future use with other parties
- Town Attorney Conflict of Interest Form
  - Woolmington, Campbell, Bent, & Stasny, P.C. represents both Sunderland and NCLT
  - Attorney requesting Selectboard Chair to sign form and waive any potential conflict of interest claims arising out of Woolmington, Campbell, Bent, & Stasny, P.C. representing NCLT
  - Motion made for Selectboard Chair to sign and submit form
